

Survey: Blended Law Clerk and Legal Assistant Roles Account for Nearly One-Third of Legal Support Jobs in Canada



TORONTO, March 21, 2018 /CNW/ - As clients seek legal services at lower costs, the need for multifaceted support staff is growing. More than half of Canadian lawyers (52 per cent) interviewed by Robert Half Legal said blended or hybrid law clerk and legal assistant positions have become more prevalent in the last two years, and 28 per cent said their organization plans to increase hiring for these roles in the next 12 months. The research also found that 30 per cent of the legal support jobs at law firms or companies are hybrid positions.

The survey was developed by Robert Half Legal, a legal staffing and consulting solutions firm specializing in placing [lawyers, law clerks and other highly skilled legal professionals](#). It was conducted by an independent research firm and is based on 150 telephone interviews with lawyers from the largest law firms and companies in Canada.

Lawyers were asked, "In your opinion, have blended or hybrid law clerk/legal assistant positions become more or less common than they were two years ago?" Their responses:*

Much more common	12%
Somewhat more common	40%
No change	38%
Somewhat less common	5%
Much less common	1%
Don't know	5%

Lawyers were also asked, "Does your law firm or company plan to increase or decrease its hiring of legal support professionals for blended or hybrid law clerk/legal assistant positions in the next 12 months?" Their responses:

Increase significantly	2%
Increase somewhat	26%
Keep the same/no change	68%
Decrease somewhat	2%
Decrease significantly	0%
Don't know	2%

"Hybrid positions that combine administrative tasks with law clerk duties are becoming more widespread as firms restructure their support teams to improve efficiencies," said Jamy Sullivan, executive director of Robert Half Legal. "To deliver quality results to clients at lower billing rates, the responsibilities of legal professionals in these blended roles are also expanding to include a variety of litigation support tasks traditionally handled by first-year associates."

Job prospects and salaries are increasing as employers compete for tech-savvy and versatile legal assistants, Sullivan observed. "Law clerks with a bachelor's degree, technical proficiency and three-plus years of experience in a high-demand specialty — such as compliance or commercial litigation — are in short supply," she said.

The Robert Half Legal 2018 Salary Guide revealed average starting salaries for hybrid law clerk jobs at a midpoint of \$47,000 in Canada, depending on the scope and complexity of the position.
